Inter-institutional Research Collaboration Research Ethics Authorization

The Grenfell Campus Research Ethics Board (GCREB) recognizes that the REBs of Canadian universities ensure that all research investigations involving human participants follow the guidelines established by the *TCPS 2 - Tri-Council Policy Statement: Ethical Conduct for Research Involving Humans*. The GCREB also recognizes that collaboration is often essential to the effective conduct of research, to facilitate recruitment of participants, and to coordinate logistical and operational aspects of research. Therefore, if a researcher at Grenfell Campus is a co-investigator of a research project which has received ethics approval from a Canadian university which follows the guidelines established by the *TCPS 2*, that researcher does not have to submit an ethics application to the GCREB. There are some legislative restrictions for out-of-province studies conducting health research involving human subjects. These studies must be reviewed by the HREB (http://www.hrea.ca/HREB.aspx). Studies conducted by the same researcher at more than one Memorial University campus, or the same study conducted by different researchers at more than one Memorial University campus, may require only one MUN REB approval (i.e., ICHER or GCREB).
