# PEDIATRIC RESIDENT RESEARCH DAY 2024



On January 25th, we held our 2024 Pediatric Residents Research Day. The day featured ten presentations from our pediatric residents. Topics included elucidating the experiences of male identifying patients with eating disorders (Dr. Ruth Chau); assessing provider interest in transitioning to the Eat, Sleep, Console approach for neonatal abstinence syndrome (Dr. Kathryn Clark); evaluating final year curriculum changes in our pediatric residency program (Dr. Alisha Poppen); an assessment of a hybrid closed-loop system on glycemic outcomes in NL (Dr. Sophia Miao); a needs assessment on breastfeeding training during pediatric residency (Dr. Hilary Price); a retrospective analysis of unintentional pediatric injuries resulting in hospitalization and death in NL (Dr. Katie Smith); assessment of an educational session for family medicine residents on pediatric procedural sedation and analgesia (Dr. Alexis Sharp); and the effects of equity, diversity and inclusion workshops on perceptions of resident trainees (Dr. Sara Trincao-Batra).

Brandon will now go on to represent our Discipline at both the Faculty of Medicine's Resident Research Symposium on Feb 5<sup>th</sup> and the National Pediatric Resident Research Competition, which is being held this May.

The judges for research day were Dr. Kathleen Hodgkinson (Memorial) and Ms. Rozane El Masri (Memorial / Janeway Pediatric Research Unit).

# **Focus on Transition to Practice EPA#1**

# Leading a general pediatric inpatient service

This EPA focuses on the independent management of an inpatient service in the role of the physician most responsible for patient care. Building on the competencies of the Core stage, this includes application of the knowledge, skills and attitudes expected of an independently practicing physician.

This includes responsibility for the overall safe quality care of acute and chronic patients, working effectively with the interprofessional team, completing administrative tasks, bed management, and supervising, coaching, assessing and providing feedback for junior learners.

The observation of this EPA is divided into two parts: patient care and interprofessional interaction/supervision.

The patient care aspects of this EPA are based on at least one week of observation caring for a patient population that is reflective of a general pediatric practice in the local context.

The Milestones for this EPA are:

#### Part A: Patient care

- 1. Demonstrate responsibility and accountability for decisions regarding patient care, acting in the role of most responsible physician
- 2. Perform relevant and time-effective clinical assessments
- 3. Prioritize patients based on the urgency of clinical presentations
- 4. Allocate health care resources for optimal patient care
- 5. Integrate best evidence and clinical expertise into decision-making
- 6. Develop plans for patient care that anticipate clinical response and progress to other settings of care, including home
- 7. Set priorities and manage time to fulfil diverse responsibilities
- 8. Integrate supervisory and teaching responsibilities into the overall management of the clinical service
- 9. Manage the mental and physical challenges that impact physician wellness and/or performance in demanding or stressful clinical settings
- 10. Coordinate treatment and follow-up across care settings
- 11. Facilitate timely access to services and resources in the health and/or social system(s)

# Part B: Interprofessional care/supervision

- **1.** Make effective use of the scope and expertise of other health care professionals
- **2.** Assign tasks and responsibilities to other team members, commensurate with their skills and patient complexity
- 3. Communicate effectively with physicians and other health care professionals
- **4.** Respond appropriately to input from other health care professionals
- **5.** Respond punctually to requests from patients or other health care professionals
- **6.** Use strategies for deliberate, positive role-modelling
- 7. Create a positive learning environment

- **8.** Provide feedback to enhance learning and performance
- **9.** Exhibit appropriate professional behaviours
- **10.**Intervene when behaviours toward colleagues and/or learners undermine a respectful environment
