

### **Publication Subvention Grant Instructions**

#### J. R. Smallwood Foundation for Newfoundland and Labrador Studies

## **Publication Subvention Grant Deadline Date**

November 25

J.R. Smallwood Foundation for Newfoundland and Labrador Studies Publication Subvention Grants (to a maximum of \$5000) are available on a competitive basis to authors to provide financial assistance for scholarly publishing that falls within the Smallwood Foundation mandate. While all forms of scholarly publication are eligible for support, priority will be given to original book-length manuscripts of merit. Book chapters and journal articles will be considered where funds permit.

J.R. Smallwood Foundation for Newfoundland and Labrador Studies Mandate: The funds are to be used specifically for the promotion and support of research in Newfoundland Studies in the areas of the Humanities and Social Sciences.

**Note:** Completed applications must be submitted via email by the deadline to **iser@mun.ca**.

## **Eligibility**

- Authors inside or outside the Memorial University community.
- Funds are limited and their allocation will be competitive in keeping with normative criteria of scholarly excellence.

#### **Term of Award**

Award must be utilized within 12 months of notification.

#### **Categories of Financial Assistance**

The Committee will consider:

- Subvention towards publication costs where the publisher makes this a condition of publication.
- Assistance towards cost of illustrative material (maps, photos, figures, and the like) aftera manuscript has been accepted by a publisher.
- Assistance towards costs of indexing the material accepted for publication.

## **Contractual Obligations**

- Acknowledgement in the published work of the subvention received.
- Deposit of one copy of the published work in Memorial University's Library.

A complete application package should be emailed to <u>iser@mun.ca</u> by the deadline. This package consists of:

- 1. A completed application
- 2. A copy of all relevant correspondence with the publisher (relevant correspondence includes readers' reports and contract)
- 3. A copy of the original work (may be forwarded via email or hard copy through regular mail)

All applicants must complete sections I, II and III and relevant sections of IV.

Note: Attach additional pages if more space is required.
